OLD GREENWICH, Conn., August 28, 2024—Ellington Financial Inc. (NYSE: EFC) (the "Company") today announced its estimated book value per share of common stock of \$13.80 as of July 31, 2024. This estimate includes the effect of the previously announced monthly dividend of \$0.13 per share of common stock, payable on August 26, 2024 to holders of record on July 31, 2024, with the same ex-dividend date.
